## THE IP SYSTEM REQUIRES BALANCE



Copyright gives authors important rights that encourage creativity and distribution. These rights are the yin to the yang of the public domain, and its contributions to access and creativity. The key is to strike the right balance between control and freedom.

"It is important to recognize that when a work enters the public domain...it does not represent the death of copyright; rather it is part of copyright's lifecycle, the next stage of life for that creative work." –Karyn Temple, former Register of Copyrights, US Copyright Office

#### WHAT IS THE PUBLIC DOMAIN?

- Essential to creativity and innovation
- Furthers US Constitutional objective: "Promote the progress"
- What is in the public domain?
  - Our collective cultural and scientific heritage, and the raw materials for future expression, research, democratic dialogue and education
  - o Creative works and inventions whose copyright or patent terms have expired, or that predated intellectual property laws
  - O Public domain aspects of those works such as raw data, facts, ideas, genres, themes, scientific principles, theories, formulae, and laws of nature


### GOVERNMENT WORKS


All works of the US government are also part of the public domain. This includes legislation, regulations, legal opinions, and hearings. It also includes the creative output from government projects, such as images from the James Webb space telescope.



## CREATIVITY

The public domain is a wellspring for creativity.







#### ACCESS

The public domain removes barriers to access. This promotes equality and makes education more affordable and interactive. Empirical studies show that public domain books are less expensive, more likely in print, and available in more editions and formats, including audiobook and Braille versions.

#### PRESERVATION

The public domain enables preservation of our cultural heritage.



By the time their copyrights expire, many works are lost entirely. An estimated 80% of films from the 1920s have already decayed beyond repair. Some older films have disintegrated while preservationists waited for them to enter the public domain, so that they could legally digitize them.

When these historical works enter the public domain, anyone can preserve and make them available, where we can rediscover them.

#### ECONOMIC VALUE

The public domain feeds the economy.

The public domain is essential to technological development.




- Science and research

## IN 2019, A GRAND REOPENING


Then for the first time in 20+ years, on January 1 2019, published works entered our public domain.
